A booking deposit of 30% of the total rental amount for the rental period will secure the booking. Booking Deposits are to be paid within 48 hours of confirmation of the amount and only once the deposit is paid the booking will be confirmed.

An additional Insurance excess and Breakage Deposit to the amount of R5000.00 will be payable together with the outstanding rental amount for the period no less than 7 days prior to collection of the trailer.

On return of the Trailer Makwela Transfrontier Safaris will inspect the Trailer/Caravan and/or goods for damages or losses and the R5000.00 Insurance Excess and Damages deposit minus excess or damages or losses will be refunded.

DURATION OF RENTAL

The minimum rental is 3 days. In calculating the number of days the day of collection together with the day of return will be counted as 1 day.

For weekends the Trailer/Caravan may be collected on a Thursday afternoon and returned on Monday morning before 10:00.

HOURS FOR COLLECTION AND RETURN

Collection and return times have to be arranged with Makwela Transfrontier Safaris during the week Monday to Friday from 8:00 to 16:00.

No collection or return after hours, Sundays or Public holidays unless by prior arrangement.

CANCELLATION POLICY

Booking Deposits are only refunded if cancellation is received 30 days prior to the collection date.

If the Trailer/Caravan or goods are returned early for any reason no refund will be considered.

If the Excess Deposit and full rental amount for the period are not received at least 7 days prior to date of collection the booking might be viewed as cancelled.



INSURANCE

Makwela Transfrontier Safaris are comprehensively insured and the rates quoted include insurance. The lessee however will be liable for any excess amounts to be paid in case of an insurance claim. The excess amount will be calculated as 10% of the claim with a minimum of R2500.00

Notwithstanding anything to the contrary the lessee shall remain liable for all damages and/or loss to any Trailer/Caravan, goods or its contents including for the period that any of the goods are not being capable of being rented out.

The lessee shall be liable for all loss or damage in the event of the insurance company failing to compensate Makwela Transfrontier Safaris for losses due to actions of the lessee.

The lessee will be fully liable for any damage to Makwela Transfrontier Safaris if:

1. The terms of the rental contract are breached.
2. Damage to the Trailer/Caravan is caused by wilful or reckless or negligent driving.
3. Driving under the influence of drugs or alcohol.
4. Water submersion or salt-water damage is caused.

The lessee is fully liable to pay for any shortages or damage to the content of the trailer, including any damage to the tyres, tent, jockey wheel, water taps, electrical connections, lights, fridge or any other part as described in the contents list.

INFRINGEMENTS

The lessee will be liable for any traffic fines and associated administration costs during the rental period.

ID/DRIVERS LICENCE

A valid non-endorsed driver's license is required with license code EB. A certified copy of the drivers licence and of the ID/Passport of the person responsible for payment will also be required.

ROAD RESTRICTIONS

Trailers and Caravans may be taken into all South Africa's neighbouring states south of the equator, for which areas Makwela Transfrontier Safaris shall issue the necessary Border Letters. All insurance cover is void if vehicles enter prohibited areas. Makwela Transfrontier Safaris reserves the right, at its sole discretion, to restrict vehicle movements in certain areas due to adverse road or weather conditions, political situations or any other reason.

REPAIRS

Emergency repairs of up to R1 000 may be effected without authorization and will be reimbursed upon presentation of receipts. When over R1 000 such repairs may be done only with the approval of Makwela Transfrontier Safaris

Initials _____ CARING FOR THE TRAILER/CARAVAN AND EQUIPMENT

The lessee agrees to care for the Trailer/Caravan and equipment as if it were his own. In the event of the Trailer/Caravan and/or equipment and/or linen being returned to Makwela Transfrontier Safaris in a very dirty condition a cleaning levy of R150 will be charged. The lessee acknowledges that he received the Trailer/Caravan in good working order and roadworthy condition, and undertakes to return the trailer in the same condition as agreed upon.

PETS

No pets are permitted in our Trailer/Caravan.

NO SMOKING

Smoking inside our Trailer/Caravan or lighting a candle or similar device inside is strictly prohibited.

LATE RETURNS

All late returns will incur a penalty at rate plus 50% per day for every day that the vehicle or goods are late. It will be regarded as a late return for every day that the goods are being repaired or for delays in replacing it, thus making the goods non-rentable.

LEGAL COSTS

The lessee will be held liable for all legal fees incurred in terms of the lessors right as stipulated in this agreement. All costs and disbursements including legal costs on the attorney and client scale incurred by Makwela Transfrontier Safaris in recovering possession of the goods/vehicles [as the case may be]; and/or in tracing the hirer or the goods; and/or in disposing of the goods; and/or in collecting or endeavouring to collect any amounts due in terms hereof are payable by the hirer on demand including collection commission, selling commission, dismantling and removal charges, costs of repairing and restoring the goods to their former condition, the costs of storage and all like charges.

JURISDICTION

The lessee hereby consents to the jurisdiction of the magistrate's court having jurisdiction over his person in respect of all legal proceedings connected with this agreement, notwithstanding that the amount of the matter in dispute exceeds the court's jurisdiction. Notwithstanding the foregoing the Lessor shall be entitled to institute proceedings against the hirer in the division of the High Court having jurisdiction in the matter.

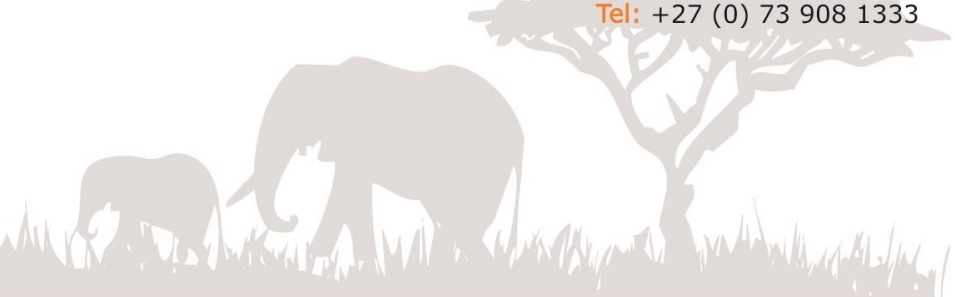
The parties hereby choose as their domicilium citandi et executandi for all notices and processes their respective home addresses as given at the beginning of this agreement.
